

# **Aron Demo Contest**

### **Plan introduction**

In this promotion, all clients who have joined Aron Groups Broker can enter the contest for 20 days each month.

### **Terms and conditions**

- The plan starts on the 20th of each month and lasts for 20 days until the 10th of the following month.
- Each client will be provided with a \$10,000 VIP account with a leverage of 1:100. This account will be closed and archived after completing the trades.

- Each position must remain open for at least 180 seconds.
